At the outset, the PCB welcomed all the members. Thereafter, Brig. K. Satyanand, SM, SEMO has taken Oath on becoming the nominated member of the Board. And later Shri S. Kiran Kumar, DRO has taken Oath on becoming the nominated member of the Board.

Before the discussion on agenda, Shri S. Keshava Reddy, Vice President and Elected Member, Ward II handed over two representations, one pertaining to allegations of misuse of official position by Shri. Md. Afzal Mohiuddin, Health Superintendent and another pertaining to request for allotment of land under A2 category for trenching/garbage management purpose. The PCB marked the representations to the CEO for action as per the rules. The CEO, then requested the Board to take up agenda points.

## **PROGRESS OF PREVIOUS BOARD MEETING**

**[ 01 ]** To consider the progress made on the previous Board meeting Minutes and also to consider the pended items if any.

**Resolution:** The CEO has drawn the attention of the Board towards the pended building plan in previous Board meeting vide CBRs under below.

- i) CBR No. 13 (1) (2) (3) (4) (6) (7) dated 26.07.2016.
- ii) CBR No. 18(3) dated 26.07.2016.

As regards the revised building plan pertaining to Shri Ch. Satyanarayana Reddy, the elected member, Shri J. Maheshwar Reddy, Ward I has raised the issue of pending building applications in unauthorized layouts and expressed the concern that no action is being taken in formulating a policy for considering the building applications of plot holders in unauthorized lay outs who have been cheated by the developers. He further argued that all such cases should be considered and permission should be given instead of considering isolated cases. Shri J. Maheshwar Reddy further stated that the Cantonment Board in any case, is providing the civic amenities and is also maintaining the roads and common areas. The CEO apprised the Board that there are several unauthorized layouts in the Cantonment area and a regularization plan has to be submitted by all the plot holders to resolve the issue once for all and in such matters the elected members have to play an active role in bringing together the residents to persuade them to get the layouts regularized. The CEO further stated that only in cases where maximum buildings have already come up, sanctions are being considered as an exception and not as a rule. The PCB directed that a site inspection of such cases in Ward No. I will be carried out by him along with the CEO and concerned Ward member. Thereafter matter will be discussed in the Board.

The CEO further informed the Board that the building applications of Sl No. 2 and 6 got erroneously included in pended items in CBR No. 13 dated 26.07.2016 even though there were no observations against the said plans. Therefore the same will be released by the office. Smt. P. Bhagya Sree, Elected member, Ward VII requested to clear the sanction of ungifted building plan pended vide CBR No. 12(5) dated 26.07.2016 as she has verified the drainage issue and found the same to be satisfactory. The Board resolved to approve following building applications on usual terms and conditions and pended the other items of Sl. No. 1, 3, 4 and 7 to be considered after receipt of reports/clarifications.

The Board resolved to approve the above building applications under section 235 of the Cantonments Act, 2006 subject to condition that the plan will be released only after Rain Water Harvest Pits are made in the plots and if no objection with regards to involvement of defence land or State Govt. property or disputed property is received within one week. CEO shall release the plinth sanction only as resolved under CBR No dated 07<sup>th</sup> August 2013. On satisfactory completion of plinth, rest of the building plans will be cleared.

The sanction for erection of the building shall be available for two years from the date of issue. If building so sanctioned is not begun within the period, the sanction will lapse. The date of commencement shall be reported / intimated to the Board and completion certificate shall be obtained.

The erection as per plan shall be completed within the period of one year from the date of its commencement but not later than 2 years from the date of issue of sanction. The plan should be adhered to absolutely in every respect.

The sanction is Municipal sanction only and is without prejudice to anyone else right on or to the land.

The date of completion shall be reported as required under section 242 of the Cantonments Act, 2006.

The sanction will be subject to receipt of NOCs from concerned authorities.

The Board resolved to approve the building application under section 235 of the Cantonments Act, 2006 subject to condition that the plan will be released only after Rain Water Harvest Pits are made in the plots and if no objection with regards to involvement of defence land or State Govt. property or disputed property is received within one week. CEO shall release the plinth sanction only as resolved under CBR No dated 07<sup>th</sup> August 2013. On satisfactory completion of plinth, rest of the building plans will be cleared.

In respect of proposal for setting up of Solid Waste Processing Plant, Smt. P. Bhagya Sree, Elected Member, Ward VII has raised serious objection to discontinuing the use of Gandhi Community hall and has also requested the Board that the garbage transit point should be shifted from the location immediately. She further argued that it is a residential locality and the transit point is causing problems to the nearby residents.

The CEO apprised the Board that at present, in order to comply with the Municipal Solid Waste (Management and handling) Rules, 2000 and the norms of Pollution Control Board, the Secunderabad Cantonment Board has entered into an agreement with Greater Hyderabad Municipal Corporation, Telangana State for transporting and treatment of Solid Waste generated in the Cantonment area on payment of Rs. 35 Lakhs per month. Besides, the Board is also incurring heavy expenditure to the tune of 15 Lakhs per month for transporting the garbage to their treatment plant at Jawahar Nagar, Hyderabad. In the meanwhile, the PEC Limited has proposed to set up a mixed Solid Waste Processing Plant at their own cost which has been considered and approved by the Board as there is no financial commitment for the Board and also in view of the Swacch Bharath mandate with respect to Solid Waste treatment.



The CEO informed the Board that it is mandatory for the Board to make arrangements for treatment of solid waste as required under various statutes/Rules and then issue cannot be ignored. The CEO further briefed the Board that the proposed treatment procedure will not involve any dumping of garbage and the plant will be able to process 20 Tonnes of garbage per hour which will be located inside a shed which will not emit any smoke or smell. The CEO further informed that in the past, due to agitation of local residents and interference of political leaders, the Turkapally trenching ground is not being allowed to be used and that there is no alternative site available. The elected members must indicate some solution in their regard. The Hon'ble MP, Shri Ch. Malla Reddy advised the Board to explore the option of purchasing a piece of land or taking on lease for Solid Waste Management (SWM) purpose. The Hon'ble MLA, Shri G. Sayanna has also supported the view and requested the Board to find a permanent solution to the issue. All the other elected members have also participated in the discussion. After prolonged discussion and debate, the PCB directed the CEO that the option of use of Turkapally trenching ground may also be explored since it has been purchased by the Cantonment Board for trenching purpose and in case of any interference, the State Govt. should be requested to provide alternative land. The CEO informed that in the past when the issue came up, similar assurances were made by the public representatives in the GHMC area, but however no progress could be achieved in the matter. The PCB then informed the elected members that there will be a garbage transit point in every ward so that there are no complaints regarding dumping of entire garbage of Cantonment in one particular ward. All the elected members have agreed to the same and CEO requested them to indicate suitable places for locating the garbage transit points and also informed the elected member, Ward VII that it is not immediately possible to close down the transit point in Trimulgherry unless alternatives are explored. The PCB directed that all possible alternatives should be explored as per the Rules and the present arrangements should continue so that no violation of municipal solid waste management rules takes place.

#### **GLR MUTATION & SUB-DIVISION ON H.NO.77, PICKET BAZAR**

[ 15 ] To consider the application dated 27.09.2016 submitted by Shri T.S.Madhu, S/o. Late. T.Ramchander Rao requesting for mutation and sub-division in respect of property bearing no.77, Picket Bazar, in Secunderabad Cantonment area.

Section 3(2): Government of India have given careful consideration to the matter and have decided that hereinafter change in the use of or sub-division of a site or erection of additional buildings, in respect of old grant sites inside notified civil areas, shall not be sanctioned by a Board without the previous sanction of the Central Government. All cases not yet finalized should be dealt with accordingly.

With reference to the letter No.SCB/EB/Sub-division of H.No.77, Picket Bazaar/3021, dated:14<sup>th</sup> October,2016, the applicant has submitted the letter vide dated:14-10-2016 stating that they are willing to execute lease as per the CLA rules in respect of the said property if the same is converted from Old grant to lease hold.

**REGULARIZATION OF HOUSE WHICH IS UNAUTHORIZED CONSTRUCTION AS PER DIRECTION IN A.S.NO.66 OF 2012 UNDER SECTION 248(1) OF THE CANTT. ACT**

[ 22 ] To consider the Shri Regularization of building plan submitted by G. Ravikanth & another in respect of open plot in Sy.No.45/P situated at Rasoolpura Village, Secunderabad Cantonment for Ground floor & First Floor belongs to Shri. G.Narsimha Chary, S/o. G.Veera Chary. The technical report has brought out the following:

1. The open plot is not abutting to any road i.e., PWD road, Municipal Road nor Cantonment Fund Road.
2. The existing building is contrary to building byelaws i.e., set backs around the building and the plot measurements at site are not tallying with the sale deed.
3. There is no existing structure in First Floor except one room whereas the applicant shown entire floor in the plan first floor.
4. NOC from Airport Authority not submitted.

The relevant file is placed on the table.

**Resolution:** The CEO briefed the Board about the facts of the case and has informed that as per the technical report, the building existing at present is not amenable to regularization as it violates building bye-laws and setbacks. More over the applicant has not submitted a factual floor plan and some discrepancies have been noticed. The Board considered and resolved that it would be appropriate to give a final opportunity to the owner/occupier to modify the building as per the building bye-laws to be carried out within a period of one month failing which demolition can be undertaken by the Board.

**EXTENSION OF TIME FOR COMPLETION -RECONSTRUCTION OF PHILIPS GODOWN CULVERT, BAPUJI NAGAR IN SECUNDERABAD CANTONMENT**

[ 23 ] To consider the request for extension of time for construction of Philips Godown Culvert, Bapuji Nagar in Secunderabad Cantonment.

Since the Philip Godown Culvert was in a dilapidated condition, an estimate was prepared for reconstruction of the culvert and the same was sanctioned in the Board vide CBR No. 31 dated 30.09.2013 and CBR No.37 dated 04.06.2014. Tenders were called for and the contract was allotted to M/s. Laxman Rao & Sons. Work order was issued to the approved contractor vide lr no. 33 dated 14.03.2016 and the date of completion is mentioned as 31<sup>st</sup> August, 2016. , The site could be handed over to the contractor in the month of September, 2016 only after shifting of poles and water pipelines by MES, HMWS&SB and SCB. The contractor vide his letter dated 17.10.2016 requested this office to grant extension of time to the said work till 31<sup>st</sup> May, 2017. After considering the volume of the work involved, it is recommended that the extension may be granted up to 31<sup>st</sup> January, 2017 for completion of the said work.

The relevant file is placed on the table.

**Resolution:** Considered and discussed the matter in detail, the CEO apprised the Board that the commencement of the work was delayed due to circumstances beyond the control of the organization and the contractor and therefore extension is recommended. Shri J. Rama Krishna, Elected Member, Ward V requested the Board to explore the possibility of building a precast culvert so that the work is completed quickly without causing any problem to the public. Lt. Col. Alip Kumar Roy, GE [South] stated that the precast system will be very costly and may result in escalation of estimates by more than double from the ongoing conventional design of construction. The CEO stated that since the tender is finalized and work order has been placed, any changes at this stage may further delay the completion of work. She suggested that the tender for another culvert at Jaya nagar is being invited where in the precast design will be floated and depending on the results, decision may be taken for adopting this method. The Board resolved accordingly to grant extension of time for completion of work.

### **PRIVATISATION OF WATER BILLING AND COLLECTION**

This model is already being successfully implemented by HMWS&SB. It is noticed from the experience of the Board that due to lack of permanent staff, outsourcing had to be resorted to from time to time. The model suggested will not only result in enhancement of revenue, but also timely billing and collection.

The relevant file is placed on the table.

**Resolution:** Considered and discussed the matter at length. The CEO explained to the Board about the proposal and the benefits of timely distribution and collection of water bills. Shri J. Maheshwar Reddy, Elected Member, Ward I, has expressed discontent that the decisions taken in the meeting held at the CEO on fixing of water charges for various categories has not been implemented so far as no instructions have been issued. The CEO informed the PCB that the issue could not



be finalized due to other official engagements of the CEO and non availability in the station. The CEO assured the Board that the matter will be finalized before the next Board meeting. Shri Keshava Reddy, Vice President, Ward II has requested for immediate action on fixing of meters in his ward to control the misuse of drinking water. The PCB directed the CEO to take action immediately. The Board considered and approved the proposed for privatization of the billing of water charges.

Ramakrishna, Elected Member, Ward V and Shri Pandurangam Yadav, Elected Member, Ward VI requested to include two applications [(i) Amaravathi Bar and Restaurant, Opp. Karkhana police station and (ii) Kanaka durga Bar and Restaurant, Leela gardens, Trimulgherry] for grant of trade license which have been received in the Office well within time. Cantonment General Hospital, Bolarum. This will facilitate the expansion of services in the CGH. The CEO further stated that the charges on account of various services in the Cantonment General Hospital have to be revised in order to make it a viable proposition. The elected members agreed that OPD charges should be revised from Rs. 2/- to 10/- each. The CEO informed that the indoor facility will be made functional from 01<sup>st</sup> December, 2016 after making all the necessary arrangements. The CEO further stated that fixing of charges for all other services will be worked out and placed before the Board.

### **URBAN PRIMARY HEALTH CENTRE AT BOWENPALLY**

[ 40 ] To consider the matter of opening of Urban Primary Health Centre at Bowenpally area, Secunderabad through NUHM, Govt. of India.

Govt. of Telangana under National Urban Health Mission has proposed to open an Urban Primary Health Centre at Bowenpally area, where in NUHM will provide all infrastructure such as providing one full time Doctor, One part time Doctor, Nurses, Material, Medicines equipments etc., from their side. The Cantonment Board, Secunderabad has to provide a building for running Urban Primary Health Centre.

Keeping in view the necessity of such facilities in Bowenpally slum, it is proposed to open the Urban Primary Health Centre Bowenpally where at present

Cantonment Dispensary is running. The permanent staff of Cantonment Dispensary will be shifted to Cantonment General Hospital, Bollaram. The proposed Urban Primary Health Centre will have far more services than the Cantonment Dispensary and diagnosis treatment will be purely on **free of cost** for which the entire expenditure will be born under NUHM, Govt. of India scheme being executed throughout India. The Health Centre will be running under the overall control and administration of Secunderabad Cantonment Board.
