Resolution: Shri J Ramakrishna, Nominated Member has raised the point that the merging and sub-division of the same plot with different measurements is in contradiction with the building and layout byelaws of Secunderabad Cantonment Board. CEO apprised the Board that these plots mentioned on the agenda side are of different size as per the sale deed and the sanctioned layout and the applicant wants to rectify the same. However, the plots are vacant on ground and the total land size of two plots remain the same i.e. 744 Sq.Yds. The CEO advised that since the member has raised a technical point, the same may be pended for want of clarity and legal position. The Board resolved that the CEO to obtain clarity on legal position and put up to the Board.

APPLICATIONS FOR SANCTION OF BUILDING PLANS

CATEGORY - GIFTED

The building plans are in accordance with the building byelaws and FSI restrictions. The site in each case is situated outside notified civil area classified as B-2 land as per the GLR maintained by the DEO, AP Circle, Secunderabad.

The layout of these colonies was sanctioned after 1974 and the societies have handed over 40% open area for civic and other amenities to the Cantonment Board, Secunderabad by a way of Registered Gift Deed as per the bye-laws.

As per the decision of the Board in its meeting held on 04th November 1997, No Objection Certificate from Airport Authority of India has not been insisted in such cases where construction of only Ground Floor is involved.

The Board resolved to approve the building applications under section 235 of the Cantonments Act, 2006 subject to condition that the plan will be released only after Rain Water Harvest Pits are made in the plots. CEO shall release the plinth sanction only as resolved under CBR No.12 dated 07th August 2013. On satisfactory completion of plinth, rest of the building plans will be cleared.

The sanction for erection of the building shall be available for two years from the date of issue. If building so sanctioned is not begun within the period, the sanction will lapse. The date of commencement shall be reported / intimated to the Board and completion certificate shall be obtained.

The erection as per plan shall be completed within the period of one year from the date of its commencement. The plan should be adhered to absolutely in every respect. The sanction is Municipal sanction only and is without prejudice to anyone else's right on or to the land. The date of completion shall be reported as required under section 242 of the Cantonments Act 2006. The sanction will be subject to receipt of NOC from concerned authorities. *Any typographical / clerical mistake with regard to details mentioned on the agenda side may be amended by the CEO in the agenda / at the time of sanction.*

The CEO informed the Board that due to typographical error the layout name at Sl. Further, the said layout is ungifted and therefore the sanction may be accorded under ungifted category.

The Board resolved to approve the building applications under section 235 of the Cantonments Act, 2006 subject to condition that the plan will be released only after Rain Water Harvest Pits are made in the plots. Shri J. Ramakrishna, Civilian Nominated Member, has raised observations in connection with building applications at Sl.No.7 and 9 on the agenda side. In respect of plan at Sl.No.7, he informed that there are shops in the subject plot and the site is being used for commercial purpose and why did the applicant submit the plan for residential building. The CEO apprised that there are structures existing on the ground and the same has to be demolished by the applicant as per plan submitted. Further, the CEO informed it is the applicant's prerogative to seek sanction either for residential or commercial building. The Board resolved to pend the subject plan for next meeting after rechecking the plan on the ground.

Further, in respect of plan at Sl.No.9, the member informed that the park which is adjacent to the subject plot has to be protected by way of construction of the compound wall as the applicant is using it as thorough fare to enter to his plot. The CEO apprised the Board that the park land will be protected after getting the work approved by the Board. The Board resolved to approve the same.

CONSTRUCTION, OPERATION AND MAINTENANCE OF BUS SHELTERS WITH CERTAIN AMENITIES IN SELECT LOCATIONS WITHIN SCB AREA ON BUILD OPERATE & TRANSFER (BOT) BASIS

[16] To consider the report submitted by the Revenue Supdt. regarding the matter of e-tenders called for "Construction, Operation and Maintenance of Bus Shelters with certain amenities in select locations within SCB Area on Build Operate & Transfer (BOT) Basis" vide this office Lr.No.SCB/RS/Bus Shelters/2022/586, Dt.03.03.2022 and the same was published in the website eprocure.gov.in. There are as many 117 bus shelters that are in existence unauthorisedly without knowledge of this office. These bus shelters though being public utility, are to be regulated as the Board is losing advertisement revenue.

Three (03) bidders have participated in the online tender and after technical evaluation of the requisite documents uploaded by the bidders, M/s. Crisis Management Services & Solutions was rejected in Technical Bid and the remaining two (02) bidders i.e. M/s. Prakash Arts Pvt. Ltd and M/s. Uni-Ads Ltd. were admitted for Financial Bid.

Accordingly, the Financial Bid of the above said firms was opened and the comparative statement is given here below:

From the BoQ Comparative statement it is observed that M/s. Prakash Arts Pvt. Ltd. has quoted the highest rate of Rs.1,36,400/- (Rupees One Lakh Thirty Six thousand and Four hundred only) per annum per each bus shelter.

The relevant file is placed on the table.

Resolution: The CEO apprised the Board that as many as 117 bus shelters, though of public utility, are operating in the Cantonment Area wherein the Board has no control. Some of these bus shelters are redundant and serve only as Advertisement Spaces. Most of them are also in dilapidated condition, serving no purpose for commuters at the Bus shelters. Further the CEO also apprised that in most of the cases, it is unaware who all are operating these Bus shelters and it is difficult to collect advertisement revenue, and as such only a meager 5 Lakh Rupees per annum is being collected by the Board. The new bus shelters are to be sanctioned on BOT basis with new infrastructure that not only serves public utility but also generates approximate One Crore Rupees per annum to the Board.

Shri J. Ramakrishna, Nominated Member, has appreciated the efforts made in this regard. The Board Considered and approved the Highest Bid quoted by M/s. Prakash Arts Pvt. Ltd. and the contract for a period of 07 years on BOT basis as per tender conditions and can be extended for a period of another 03 years.

STITCHING CHARGES OF UNIFORM CLOTH TO THE ENTITLED STAFF OF THE CANTONMENT BOARD, SECUNDERABAD FOR THE YEAR 2022-23

[17] To consider the report submitted by the Store Keeper as per proposal made by the Employee Union for payment of stitching charges in cash to the entitled employees of Secunderabad Cantonment Board.

The entitled categories of employees of Cantonment Board, Secunderabad are eligible to draw two pairs of uniform cloth once in two years. The stitching of uniform was carried out through approved firms/contractor and the stitching charges were paid to the contractor through Stores department. However, since last two occasions, the employees are not satisfied by the stitching. Hence, it is proposed that an amount of **Rs.550/-** (Rupees Five hundred and Fifty only) per employee to be paid to the entitled employees for stitching charges **per pair**.

The financial implication involved is of Rs.3,44,300/- (Rupees Three Lakhs Fourty Four thousand and Three hundred only) towards stitching charges for two pairs to the entitled employees for two years.

The relevant papers are placed on the table.

Resolution: Considered and approved.

ENHANCEMENT OF TAX RATE

[18] To consider the matter of revision/enhancement of tax rates for the properties in Secunderabad Cantonment as per the sub-section (1) and (2) of Section 66 of Cantonments Act, 2006, to bring it at par with the neighbouring corporation, GHMC.

Office Note: At present, the Cantonment Board, Secunderabad collects the property tax as under.

* The Water Tax rate @ 6% per annum on the gross annual letting value of all house buildings, houses and lands not having private pipe connections which are situated within 250 yards of the nearest public water stand post.

** The Special Conservancy Tax is levied only on commercial properties.

The total consolidate tax rate is 24.60% on Residential buildings and 27.60 % for Commercial building and rates have not been changed for last 30 years. Hence it is proposed to enhance the house tax by 3%.

The relevant file is placed on the table.

Resolution: CEO apprised the Board that the present tax rate is not enhanced from the past 30 years and therefore the said enhancement in the tax rate is proposed at par with GHMC rates. Shri J Ramakrishna, Elected Member informed that due to the triennial revision which is done on a regular basis, the tax incidence has been increased. Considering these facts the enhancement rate to residential buildings be limited to 1%. The Hon'ble MLA, Shri G Sayanna, also expressed the same. The PCB has directed the Dy. CEO to submit comparative analysis of existing and proposed tax incidence vis-a-vis GHMC. The Board resolved to take up the matter in the next Board meeting.

PROPOSAL FOR CHANGE OF PURPOSE OF LANDS IN RESPECT OF GLR SY.NO.708, SECUNDERABAD CANTONMENT

Ref: Directorate General, Defence Estates, Delhi Cantt. Letter No.738/225/L/DE/SC/MISC/2021 dated 27.12.2021 and PD DE, SC, Pune letter No.3044/DE/SC/L/Class 'C' Land/Gen/ Dt.09.02.2022

[19] To consider the report submitted by Engineering Branch for Change of Purpose of lands in respect of GLR Sy.No.708, Secunderabad Cantonment.

As per the report, GLR Sy.No.708 is classified as "C" to an extent of 37.565 Acres being utilized for Sports and Cultural Activities. To avoid encroachment of said land and to put the said land for fulfilment of one of Board's duties under section 64 of Cantonments Act, 2006, a need is felt for changing the purpose of land from 'Sports and Cultural Activities' to 'Sports & Cultural Activities and Remunerative Assets' in GLR.

The Board may consider and approve the same so that necessary proposals may be forwarded to the competent authority for change of purpose as follows:

The CEO may take further necessary action as per the provisions of Act and rules in force and initiate a proposal to the competent authority for its sanction. Further the CEO is also authorized to engage a consultant to study and submit the feasibility report/analysis for the usage of above land for the purpose recommended, to the Board.

REGISTRATION OF ENGINEERS/ARCHITECTS IN SECUNDERABAD CANTONMENT

[20] To consider the report submitted by the Engineering Branch regarding registration of Engineers/Architects in Secunderabad Cantonment area for drawing building plans and layout plans as per the Building bye-laws and layout bye-laws of Secunderabad Cantonment Board.

As per the report, this office has invited applications from the Licensed Engineers and Architects already registered with neighbouring Municipal bodies to be registered as Licensed Engineers/Architects with the office of the Secunderabad Cantonment Board on 23.02.2022. The Engineers/ Architects possessing the required qualification i.e. B.Arch(Architecture), B.E.(Civil Engineering), Diploma in Civil Engineering, B Tech (Civil Engineering), M Tech (Structural Engineering) and having five years experience with Greater Hyderabad Municipal Corporation (GHMC) or Hyderabad Metro Development Authority (HMDA) or Cantonment Board or surrounding Municipalities for drawing building plans and layout plans as per the Building bye-laws and layout bye-laws of the respective municipalities were asked to apply by sending their resume along with attested certificates in support of their claim addressed to the Chief Executive Officer, Office of the Secunderabad Cantonment Board, Sardar Patel Road, Court Compound, Secunderabad.

Subsequently, the applications were scrutinized and the following eight (08) applicants possessed the desired qualification as asked for and recommended by the Engineering Branch.

[21] To consider the matter of "Extension of Housekeeping services contract period at Cantonment General Hospital, Bolaram", this office has called for e-tenders for the "Annual conservancy contract for the work of sweeping of colonies/main roads in Secunderabad Cantonment area" vide Tender Notice No.SCB/HS/ETen/Sweeping/2020/737, Dt.17-04-2020. Smt. S Nageshwari has got the work allotted at the lowest rate of 3.5% on wages and equipment in the unit Nos.3 & 9 and the same was approved by the Board vide CBR No.03, Dt. 29/05/2020.

Subsequently, the Cantonment General Hospital, Bolaram has converted to dedicated COVID hospital in the month of May 2021 vide circular agenda No.01 Dt. 29th April 2021 and the said contractor Smt S Nageshwari got awarded the work to engage 1.5 Units of Manpower (1+18+9=28) as Aayas, Ward Boys and Housekeeping for the Cantonment General Hospital - COVID Hospital for a temporary period of six months from 01/07/2021, from the existing contractor at the same rate i.e., +3.5% on wages and equipments to work at Cantonment General Hospital, Bolaram and the same is approved by the Board vide CBR No.15, Dt. 08/06/2021.

If approved, the contract period of housekeeping services may be extended for further period of six (06) months.

Resolution: Considered and noted.

UPGRADATION OF TWO POSTS OF ASSISTANT MEDICAL OFFICERS TO THE POSTS OF RESIDENT MEDICAL OFFICERS (SPECIALIST)

[22] To consider upgradation of two posts of Asst. Medical Officer in the scale of pay of Rs.40,270-93,780 (pre-revised - 2015) to the posts of Resident Medical Officers in the scale of pay of Rs.49,870-1,00,770 (pre-revised - 2015) equated to the post of Deputy Civil Surgeon in the Directorate of Health and Family Welfare Services of Andhra Pradesh which is being followed by the Telangana State Govt. This is essential as the Hospital infrastructure has been improved, now functioning round the clock with Labour Room and Operation Theatre facilities in the field of Gynaecology. The Hospital is also equipped with ICU, taking care of Covid patients since May, 2021.

The post of Resident Medical Officers will be a promotion post from the existing post of Assistant Medical Officer (AMO) and possessing Post Graduation qualification in Gynaecology / Medicine / Child Health with minimum 04 years of service as AMO or Diploma in Gynaecology / Medicine / Child Health with minimum 09 years of service, and willing to occupy the residential quarters in the hospital premises. In case, no such AMO is found suitable or available, the post be filled up by direct recruitment with qualifications of MBBS, MD in Gynaecology / Medicine / Child Health with minimum 04 years of experience in a Govt. Hospital and equivalent to the post of AMO. The promotion to the post of existing post of Medical Superintendent in the scale of pay of Rs.61450-105810 (pre-revised - 2015) will be henceforth filled from the post of Resident Medical Officer and will be treated as promotion post.

The posts of Assistant Medical Officers are to be upgraded to the posts of Resident Medical Officers in the scale of pay of Rs.49,870-1,00,770 (pre-revised - 2015). In this regard, 01 post of Mazdoor, carrying the pay scale of Rs.13,000 -40,270 (pre-revised - 2015) is to be surrendered. There is no additional financial implication in upgradation of posts after surrendering the 01 post of Mazdoor.

Office report along with connected papers are placed on the table.

Resolution: Considered and approved. The Board further authorized CEO to take the necessary action in this matter to take it before the competent authority for approval.
