However, remaining 09 bidders have qualified for in technical evaluation and proceeded for opening of financial bid. Accordingly, the financial bids were opened by the committee.

The 09 bidders have quoted the same percentage of Service charge i.e. (+) 3.85 % on minimum wages, hence, to finalize the tender and for awarding contract, the tender was further processed in online through GeM portal by selecting the option of "*Run L1 Selection*". Wherein, M/s. Sai Security Services have been selected as L1 bidder (selected by GeM Portal " *as System Selected*").

The Board may consider and approve the above L1 bidder "M/s. Sai Security Services" with percentage of Service charge of (+) 3.85 % on minimum wages.

Further, remaining Eleven (11) bidders have qualified in technical evaluation and the same were considered for opening of financial bid. Accordingly, the financial bids were opened by the committee.

Whereas, all the eleven (11) bidders have quoted the same profit percentage i.e. (+) 3.85% on minimum wages, hence, to finalize the tender and for awarding the contract, the tender was further processed in online through GeM portal by selecting the option of "*Run L1 Selection*". In this connection, the Engineer-in-chief (R&B), SSH, TIMS Alwal submitted the building plans to Chief Executive Officer, Secunderabad Cantonment Board for approval under Building Bye-Laws, Cantonment Board Secunderabad, "Nothing in these bye-laws shall apply to Government buildings. In the case of Government buildings, a formal notice only of proposed building with a ground plan showing the locality and site shall be forwarded to the Cantonment Board, for information". And u/s (3) of The Government Buildings from Municipal Laws to regulate the erection, etc., of buildings within municipalities-reasonable note of the proposed work shall be given to the Municipal authority before it is commenced".

It is to inform that, previously an application submitted by the Executive Engineer, South Buildings Division, Govt. of Telangana for construction of 10 court complex (Ground+5 Floors) in the premises of City Civil Court, Secunderabad, was also noted in the Board agenda vide CBR No.24(B) Dated 09.04.2015 for approval.

The relevant file is placed before the Board.

Resolution: CEO apprised the Board about the application received from the Telangana State Govt. authority for proposed construction of Super Speciality Hospital (G+8) - Telangana Institute of Medical Sciences (TIMS), with 34 Departments with a total capacity of 1200 beds.

The concerned officials from the Telangana State Govt. of Engineer-in-Chief (R&B) Buildings & National Highways, department technical staff also came to the meeting and informed that Site Plan, Building Plans and NOC for Height Clearance from the Airport Authority of India is also submitted. Further, they have informed that correspondence has been made with the Estate officer of the Rashtrapati Nilayam from a security point of view, and stated that there will be a security audit conducted by the Police Department for the same. The PCB informed that the security audit should also be conducted for the adjoining Army area by the Police Department along with Army officials of the Telangana and Andhra Sub-Area (TASA).

The CEO, informed the Board that there should be a proper drainage system for connecting the drainage line to the main line. For which, State Govt. officials said that they will make a provision for connecting that drainage line to the nearby drainage main line. CEO also enquired about provision of water supply for the proposed construction, the State Govt. officials said that they will arrange for a dedicated water supply line in coordination with HMWSSB.

Shri J. Ramakrishna, Nominated Member informed the Board that there are two colonies namely G.V. Reddy Colony and Om Sai Colony nearby the proposed site which have long pending drainage issues, and requested the State Govt. officials to connect the line of these two colonies to the main line in their proposed drainage line work. They agreed for the same and informed that STP is also proposed for the hospital.

CEO informed that Board may levy charges at Rs.700/- per Sq.mtr as Infrastructure Development charges in view of additional burden on infrastructure due to setting up of the 1200 bedded Hospital. PCB stated that as the proposed construction is a Hospital for public usage, which will be useful for the residents of Cantonment area and also the Board may consider to levy the charges of Rs.500 per Sq.mtr.

The Board considered the proposal and approved the Building plan submitted by the Engineer-in-Chief (R&B). Buildings & National Highways, Government of Telangana in GLR Sy.No.157 (B2 Land) for Ground + 8 Floors for a total area of 1,32,857 Sqm.

The Board also resolved to levy Infrastructure Development Charges of Rs.500/per Sqm. The Board also resolved that the State Government authorities should inform the Board if any changes from the sanctioned plan are taken up, and also to include the Chief Cantonment Planner and the Cantonment Engineer in the implementation of the project where such deviations are proposed to be made. The Board also resolved that security audit should be conducted for the RP Nilayam as proposed and also for the adjoining Army area by the Police Department along with Army officials of the TASA.

DIRECTIONS OF TELANGANA STATE POLLUTION CONTROL BOARD

[11] To consider and note the orders of Telangana State Pollution Control Board vide Order No. 15-RR-II/TSPCB/ZO-HYD/TF/2023-161 dated 24.05.2023, directing the Cantonment Board to comply with the directions laid thereunder and stated that the subject directions were issued under section 33(A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and the Pollution Control Board has issued the following directions to Secunderabad Cantonment Board to comply with.

- i. The Secunderabad Cantonment Board shall provide proper I&D structure system to collect and divert the sewage joining into the natural storm water drains.
- ii. The Secunderabad Cantonment Board shall provide STP of suitable capacity to treat the sewage generated from the colonies in the area. Proper study shall be carried out to assess the quantity of sewage generated keeping in the future requirements on quantity of sewage to be generated.
- iii. The I&D channels shall be connected to the proposed STP and the treated waste water shall be reused for gardening purpose in the area.
- iv. Secunderabad Cantonment Board shall furnish a detailed Action Plan with timelines to treat the Sewage generated in the area within 15 days.

In this regard, the Brief of the case is furnished as under:

Dr. M.S. Tejaswari, D/o. Late M Sathyanarayana Reddy, has filed an Original Application bearing No. 97 of 2022 before the National Green Tribunal, South Zone at Chennai, regarding the sewage accumulated in her land in Revenue Sy. No. 96 to 99, forming part of GLR Sy. No. 352/Part, Trimulgherry Village, Secunderabad Cantonment. It is informed that the Officials of Telangana State Pollution Control Board, have inspected the petitioners land and surroundings on 03.11.2022 and observed that untreated sewage from the dwellings in Northern side of the petitioners land was entering into their land and into the open well and the Pollution Control Board have collected waste samples from the open well and the analysis results indicating that the untreated sewage water was entering into the open well situated in the petitioners land. Therefore, Environment Engineer, TSPCB, vide letter No. 15/TSPCB/RP-MDC/2022/533, dated 08.12.2022, directed the Cantonment Board to take immediate measures for prevention of untreated sewage water discharges and provide necessary treatment system for the sewage generated from the households by giving 15 days time for reply if any from Secunderabad Cantonment Board. In response to the above a detailed reply was sent to the Executive Engineer vide this office letter No.SCB/EB/NGT/3474, dated 27.12.2022, by furnishing all the vital details in connection with the subject matter. The important issues involved in the subject matter are as under:

- It is to state that, the subject land on which the Complainant i.e., Dr. M.S Tejaswari, alleged to be the owner, is classified as B-2 land forming part of GLR Sy.No 352/P, Trimulgherry Village and placed under the management of State Government.
- Previously, one late M. Satyanarayana Reddy, father of the Petitioner, had submitted a Layout for approval for formation of housing plots in the subject land Adm. Ac.03-11 Gts. in Sy.No 96 to 99 forming part in GLR Sy.No.352(P) which was sanctioned vide CBR No.30 dated 06.02.2013, whereby it was proposed to lay residential colony by converting agricultural land into plots. In the said Layout, the father of the Petitioner has clearly demarcated that through an underground pipeline, the upstream sewage can be discharged connecting to an open nala in the downstream. However, the process could not be taken place, as the developer has not complied with the observations of the higher authorities of Ministry of Defence, which is the final authority to release the sanction of Layout.
- iii. Further, it is to state that there is a small village/hamlet known as Chinna Kamela where in around 250 residential houses are in existence from the past 50 years, which colony is situated on the upstream side of the Petitioner's land.
- iv. The drainage from the residential area is flowing through natural gradient and ends in a cesspool/agricultural kunta located in the subject land belongs to the Petitioner and from their land, there is no proper outlet for discharge of these effluents. This office has made attempts to convince Dr. M.S. Tejaswari and her brother to construct a proper underground drain pipeline through their open land to discharge the effluents, as shown in the Layout of their Father, but they have not agreed to the request and obstructed the passage of storm/drain water into their property by depositing construction waste, building material and debris resulted in stagnation of the sewage and storm water in the upstream area of Chinna Kamela between the dwelling houses and the Petitioner's land and causing dangerous highly contagious diseases and creating severe unhygienic conditions.

- v. In order to prevent stagnation of drain water and to curb unhygienic condition in vicinity and to release the stagnated sewage into the cesspool, the local people have removed the blockage and afterwards, the Secunderabad Cantonment Board has facilitated the free flow of sewage into cesspool created in the subject property. Afterwards, issued a Notice dated 16.02.2022 u/Sec. 230 & 224 of Cantonments Act 2006 to the Applicant and her brother for construction of underground drain line across their property, so as to discharge the sewage into the open nala.
- vi. Subsequent to issue of this Notice, the following events have taken place and the details are as under:
 - a. Being aggrieved by this office Notice dated 16 02.2022, they filed Writ Petition No.8942/2022 before the learned Single Judge of the Hon'ble High Court of Telangana and obtained an Interim Order restraining this office from interfering with their possession and also directed not to lay any drainage pipeline through their property. This office filed a Vacate Stay Petition along with Counter Affidavit to vacate the Interim Order granted.
 - b. Pending Writ Petition, the Division Bench of the Hon'ble Hon'ble High Court has directed to post all the connected Writ Petitions of the Petitioners before the Division Bench. After hearing both the parties, a Common Order dated 02.03.2022 was passed in WP No.8942 of 2022 and 17313 of 2021 (filed for a direction to the Cantonment Board to prevent laying of a drainage pipes through their property) directing the Applicant and her Brother, M.S. Raghavender, to appear before the Chief Executive Officer of the Secunderabad Cantonment Board, and participate in the enquiry pursuant to the Notice issued to them on 16.02.2022 and the Chief Executive Officer was directed to pass appropriate final orders.
 - c. Pursuant to the direction given by the Division Bench, the Applicant and her Brother along with their Advocate, have appeared before the CEO, SCB on 07.03.2022 and made certain proposals on the issue of discharge of sewage through underground discharge. On such suggestions, before passing a Final Order, a Technical Committee was appointed by the Secunderabad Cantonment Board to submit a feasibility report. Meanwhile, vide an Interim Order dated 09.03.2022, the Applicant and her Brother were directed not to block the existing drain line until alternate arrangements are made as per the feasibility report.

- d. Aggrieved by this Interim Speaking Order, Dr. M.S Raghavendra (Brother of the Applicant) filed a Writ Petition in WP No.19579/2022 before learned Single Judge of the Hon'ble High Court of Telangana against the Secunderabad Cantonment Board and pending Writ Petition, the Hon'ble Court by its Order dated 19.04.2022 directed the CEO to dispose of the matter finally within a week by 26.04.2022 as per the directions of the Division Bench in WP No.8942 of 2022.
- e. Accordingly, the CEO, SCB passed a final speaking order dated 23.04.2022 whereby, the Board has decided to lay underground drain/storm water pipeline through the properties of the Applicant and her Brother by assigning valid reasons.
- f. Aggrieved by this final order, both the Applicant and her Brother, have filed one more Writ Petition in WP No.22126/2022 before learned Single Judge of the Hon'ble High Court of Telangana. Pending Writ Petition, the Hon'ble High Court passed an Interim Order dated 29.04.2022 directing both the parties to maintain Status Quo.
- g. Subsequently, this office has filed Counter Affidavit and Vacate Stay Petition in both the Writ Petitions i.e., W.P. No. 19579/2022 and W.P. No. 22126/2022 and the same are pending for adjudication. In view of the Interim Order of Status Quo granted by the Hon'ble High Court, and since the matter concerning the discharge of sewage is sub-judice before the Hon'ble High Court of Telangana, the Secunderabad Cantonment Board could not take any further action on discharge of sewage from the upstream area.
- vii. Subsequently, the Applicant has approached the Hon'ble NGT, Chennai, by way of filing O.A. No.97 of 2022 which is pending and the Secunderabad Cantonment Board is directed to file its reply. Their reply affidavit was filed on 16.02.2023.
- viii. Further, a letter was issued by the Environmental Engineer, vide letter No. NGT-97/MDC/TSPCB/2023-56, dated 17.04.2023 to attend the meeting before the task force committee proposing to review the case on 26.04.2023. The representative of Secunderabad Cantonment Board had appeared the review meeting.
- ix. Later on the subject order was passed without considering the replies furnished by this office and issued adverse orders even before the finalization of the original Application No. 97, at the National Green Tribunal, Chennai.

Therefore, immediately after receiving the subject order of Telangana State Pollution Control Board on 29.05.2023 by this office, the matter was taken up with Cantonment Legal Advisor and requested to furnish the legal opinion regarding the further course of action to be taken in this regard and the legal opinion received from the CLA is placed on table.

Apart from the action suggested by the CLA it is proposed to prepare a detailed action plan for resolving the issue permanently and in consonance with earlier decision of the Board vide CBR No. 6, dated 10.05.2023, a detailed project report along with its feasibility may be obtained by engaging consultancy services who has expertise in the similar projects to improvise the hygienic conditions of the vicinity.

The relevant file is placed before the Board.

Resolution: The Board considered the matter in view of the Legal Opinion given by the CBLA, which says that, since the Hon'ble High Court passed an Order of Status Quo to be maintained by both the parties regarding underground drain system to be laid on the disputed area and even on the same issue, Dr. M.S. Rajeshwar had also filed an Application before the Hon'ble National Green Tribunal, Chennai, for various reliefs and the same is pending, at this juncture, the Pollution Control Board ought not have issued the above mentioned directions to the Cantonment Board through their proceedings dated 24.05.2023. As by virtue of such Proceedings, the Pollution Control Board is also contemplating to initiate prosecution proceedings in case of non-compliance of its directions, the option available to your Authority is, to file a Writ Petition before the Hon'ble High Court of Telangana, challenging the proceedings of the Pollution Control Board dated 24.05.2023.

The Board considered and resolved to provide a STP of suitable capacity by requesting HMWSSB to execute the specialised work. The HMWSSB be requested to explore the feasibility of installation of STP at the site, to prepare a Detailed Project Report and to install STP if feasible. Also to request them to complete the work expeditiously in view of the Telangana State Pollution Control Board order dated 24.05.2023. The Board authorised the CEO to incur necessary expenditure for installing the STP.

The Board also resolved that, the office to intimate the Telangana State Pollution Control Board about the Status-Quo Order of the Hon'ble High Court and the pending application filed by the complainant before National Green Tribunal, and hence not to initiate prosecution proceedings against the Board.

The Board further resolved that if the Telangana Pollution Control Board initiates prosecution proceedings against the Secunderabad Cantonment Board under Water (Prevention and Control of Pollution) Amendment Act, 1988, then the same to be challenged by filing Writ Petition in the Hon'ble High Court as advised by the Cantonment Legal Advisor.

REPAIRS AND MAINTENANCE OF PUMP MOTORS, INCLUDING ITS SPARES, OCB'S & ELECTRICAL INSTALLATIONS RANGING FROM 25 HP TO 250 HP AND INSTALLATION OF PUMP HOUSE CONTROL PANELS OF VARIOUS PUMPING STATIONS OF SECUNDERABAD CANTONMENT

[12] To consider the report submitted by the Water Supply department with regard to matter of e-tenders called for "Repairs and Maintenance of Pump Motors, including its spares, OCB's & electrical Installations ranging from 25 HP To 250 HP and installation of Pump House control panels of various pumping stations of Secunderabad Cantonment" vide Tender Notice No. SCB/SWW/ETen/25-250HP/2023-24/754, Dt. 18-04-2023, this office has received 5 bids through defproc.gov.in.

The details of the tender are as under:

Therefore, if approved, the above tender may be accepted and agreement for the award of contract will be made to L1 bidder.

The relevant file is placed before the Board for consideration.

<u>Resolution</u>: Considered and approved. Further, the Board also approved the continuance of the existing contract till finalisation of this contract / agreement.

IMPROVEMENT WORKS – WATER SUPPLY

[13] To consider and note the report submitted by the Supdt. Water Works with regard to revised estimate for the work "laying of 100 mm dia DI pipeline for improvement of drinking water supply to residents of Laxmi Narasimha Colony, Bowenpally, Secunderabad Cantonment".

As per the report, the said work has approved vide CBR No.3(6) dated 19.10.2020 for an amount of Rs.10,30,000/-. Wherein, the estimate has been revised to Rs.14,80,000/- as per the approved tender rate for the year 2023 and the increase amount is of Rs.4,50,000/-. As the location of work does not fall under RWA, colony development charges of Rs.10,000/- per connection per household cannot be collected. Hence, the entire work is to be funded by Cantonment Board.

The relevant file is placed before the Board.
